The personal data processed are stored at the registered office of the Poligrafico for the time necessary to fulfill the contractual obligations underlying this delegation as well as for that prescribed by civil, fiscal and regulatory laws and in any case for no more than 10 years from the termination of the contractual relationship with the delegating. For the pursuit of the processing purposes described above, no decision is made based solely on automated processing. The personal data acquired will not be disseminated and will not be transferred to third countries outside the European Union. The data of the Delegate are also processed by appointed "internal managers" - whose constantly updated list is available on the website www.privacy.ipzs.it - as well as by persons specifically authorized for processing by the Data Controller, pursuant to the GDPR. At any time, the Delegate, as an interested party, can exercise - within the limits of the law - the rights provided for by art. 15 and ss. of the GDPR by means of a request sent to the Data Protection Officer (RPD) or Data Protection Officer (DPO) of the Poligrafico at the following address: Via Salaria, 691 - 00138 Rome, or by e-mail to the following e-mail addresses: privacy@ipzs.it or rpd@pec.ipzs.it.
